Overview

Current criteria are based on:

- Credibility years speaking experience, client contact details and sponsor backing
- Financial income from speaking-related business (not limited to speaking), and
- Professionalism contribution to PSA and compliance with ethics.

To ensure equity for our professional members, we will offer two defined routes to Fellowship, each requiring a minimum income threshold and demonstration of our values but balanced differently. The criteria for the two routes will be based on:

- Credibility years speaking experience, client testimonials
- Financial income from speaking-related business (not limited to speaking)
- **Respect and connection** Ethics, PSA involvement, mentoring and developing others
- Excellence continuing professional development (Speak More and Speak Better)
